Speaker: Our speakers were two participants of Teen Court. They spoke about their experiences. Both felt that the experience helps them think about right and wrong, providing life lessons so kids understand the consequences of making mistakes.

- The MF Police Dept. refers 1st time youth offenders, ages 12-16, to Teen Court to be sentenced by a jury of their peers, with a local attorney serving as judge. Teen Court allows a free-pass for 1st time offenders to serve their sentences without a municipal record.
- Offenses range from vandalism, theft, smoking, and disorderly conduct.
- All participants are anonymous, and the hearing is confidential. If anyone is caught talking about it, its considered Contempt of Court and carries additional penalties, then goes back to the municipal court.
- Sentences consist of 2 jury duty nights in combination with letters of apology, community service, or essays regarding the offense.

Chief Anna Ruzinski commented that a huge percentage of defendants judged in Teen Court DO NOT re-offend.

Guests: Our guests today were Ed Mangioni, who found us via the internet, and Ann Nischke. LeRoy introduced a young man who would like to do some volunteer work.

Raffle: Mary Metzger won the card raffle and pulled the 2 of diamonds. After Ed won \$266.50 last week, \$397 was donated to the Menomonee Falls Food Pantry.

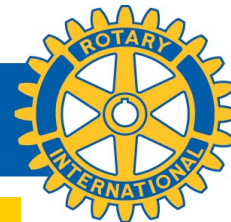
